Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Administrative:

We held a hearing for groom Placido Olivera-Chavez, for having a firearm on the licensee's grounds, without written permission. The decision of the Stewards, after considering all testimony presented at this hearing, was to fine Mr. Olivera-Chavez \$500.00 for this violation. *(It is noted that the weapon, a 9mm semi-automatic pistol seized by DTRC personnel with assist from Delaware Park security, was released to the Delaware State Police. Olivera-Chavez was thereafter evicted from the grounds by Delaware Park Security with instructions not to return under penalty of arrest for criminal trespass)*

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. Joshua Navarro, the scheduled rider on the #3, "Lily's Peak," was changed to Kerwin Clark; no double jocks mount. #5, "Little Pisano," was eased past the finish line by its rider who reported that his horse was not traveling well, had difficulty breathing, and was tired. #6, "Imperial Devil," stumbled at the start.

FIFTH RACE – ON THE TURF - POST TIME – 3:15 p.m. OFF TIME – 3:19 p.m.

Victor Carrasco, the scheduled rider on the #7, “Paper Street,” was changed to Javier Santiago; no double jocks mount. **INQUIRY AT THE START AND IN THE STRETCH RUN** - Hold and claim of foul by Horacio Karamanos the rider of #5 “Papadopalous,” against Forest Boyce the rider of the #2, “Troubled Waters,” for coming out down the stretch, carrying out and impeding his horse. After reviewing the video, the Stewards determined that the #2 came out carrying out and impeding the #5. The #2 was disqualified from 1st and placed 2nd behind the #5 who was placed 1st for interference in the stretch. #8, “Master Zeues,” reared at the start, breaking in the air. No action was taken, concerning the incident at the start.

After a two-way shake, #9, “Super Sharp,” was claimed by Mary Eppler Racing Stable Inc. – Mary Eppler.
