Approved scratches for today, reviewed and filed veterinarian daily treatment sheets and blood gas test results.

Equine Forensic Drug Testing:

Post-race test results from L.G.C. Science revealed the following:

- Sample #50551 from August 21, 2014, is on hold awaiting a certificate of analysis.
- Sample #50566 from August 23, 2014, is on hold awaiting a certificate of analysis.
- Samples #50573 and #50575 from August 25, 2014, are on hold awaiting a certificate of analysis.

Administrative:

We received the results for trainer Murray Rojas split sample, sent to Industrial Lab in Wheat Ridge Colorado, which confirmed the presence of “Dexamethasone” which was discovered in the post-race sample #44839 from the horse “Barracuda Wayne” who finished 1st in the 3rd race on July 12, 2014.

FOURTH RACE – POST TIME – 2:48 p.m. OFF TIME – 2:49 p.m. #1, “Lovely Maria,” was selected for a blood gas test.

ORDER OF FINISH – “1 - 7 - 2 - 3.” Starters - 7

FIFTH RACE – POST TIME – 3:18 p.m. OFF TIME – 3:19 p.m. Jose Vega the scheduled rider on the #5, “Proud Patriot,” was changed to Joshua Navarro; no double jocks mount. #4, “Seriously Simon,” was a vet scratch. #7, “Trace Screen,” was selected for a blood gas test. #1, “Same Time,” was claimed by Autobahn Racing Stable Inc. – Ruben Monjes.

ORDER OF FINISH – “1 - 2 - 7 - 5.” Starters - 6

SIXTH RACE – POST TIME – 3:47 p.m. OFF TIME – 3:48 p.m. #8, “Lust for Diamonds,” was a vet scratch.

ORDER OF FINISH – “6 - 1 - 3 - 5.” Starters - 7

SEVENTH RACE – POST TIME – 4:16 p.m. OFF TIME – 4:18 p.m. #5, “Comme Chez Soi,” was selected for a blood gas test.

ORDER OF FINISH – “3 - 2 - 4 - 5.” Starters - 6

EIGHTH RACE – POST TIME – 4:46 p.m. OFF TIME – 4:52 p.m. Jose Vega the scheduled rider on the #1, “Hot Rod Lincoln,” was changed to Yamil Rosario; no double jocks mount. The #1, “Hot Rod Lincoln,” was a late scratch by the Stewards, as the rider Yamil Rosario reported to Associate Commission Veterinarian Richard Brown that he had hurt his elbow and could not ride the horse. The #1 was sent back to the paddock for a change of riders but no riders were available, so the horse had to be scratched. #5, “Shadowrun,” pulled up lame after the race at the 7/8 furlong marker. The #5 was examined by Dr. Richard Brown, who said the horse had re-bowed the right front tendon. Subsequently, “Shadowrun,” was removed from the racing surface via horse ambulance. The rider of the #5 Jomar Ortega had dismounted, unsaddling the horse. #4, “Jericho Call,” was selected for a Stewards special test.
