Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

### **Equine Forensic Drug Testing:**

Post-race test results from L.G.C. Science revealed the following:

- Samples #50707, and #50743 from Wednesday, September 17, 2014, are on hold awaiting a certificate of analysis.
- Sample #50661, from Thursday, September 18, 2014, is on hold awaiting a certificate of analysis.
- Sample #50686, from Saturday, September 20, 2014, is on hold awaiting a certificate of analysis.

### **Administrative activities:**

Monday, September 29, 2014: Trainer Murray Rojas waived her right to a formal hearing concerning the positive test for Dexamethasone in the sample, #44839 taken from the horse BARRACUDA WAYNE” who ran in the 3<sup>rd</sup> race on July 12, 2014. The official laboratory reported that the sample in question contained 94 picograms per milliliter of plasma. The split sample sent to referee laboratory, Industrial Labs at the request of Trainer Rojas, confirmed the positive result. Subsequently, Ms. Rojas was fined \$1,000.00 and the horse, “BARRACUDA WAYNE was disqualified from all purse monies earned in the 3<sup>rd</sup> race on July 12, 2014.
