Administrative activities conducted on Tuesday, October 14, 2014:

A hearing was held for exercise rider Bradley Moats. The hearing was for testing positive for Cocaine, a first offense, on September 20, 2014. After appearing at a hearing, Mr. Moats was advised that he needs a letter of recommendation from a drug and alcohol counselor, prior to his license being considered for reinstatement.

#5, “Fulton Street,” pulled up lame at the seven-eighths following the race. The #5 was examined by Commission Veterinarian, Jane Teichner who informed the Stewards that the horse had reinjured its left front suspensory. Dr. Teichner requested the horse ambulance transport the equine to its stall. The rider, Victor Carrasco was not injured, as he had dismounted the horse without mishap. #3, “Fourleaf Street,” was selected for a blood gas test.
