Approved scratches for today, reviewed and filed veterinarian daily treatment sheets and blood gas test results.

Administrative:

Associate Commission Veterinarian Kathleen Picciano is performing mandatory sample collections for the Grade III OBEAH STAKES.

Equine Forensic Drug Testing:

Post-race test results from Truesdail Laboratories, Inc. revealed the following:

- All Samples from June 9, 2015 are clear.
- All Samples from June 10, 2015 are clear, with the exception of sample #14267 which was placed on hold.
- Truesdail Laboratories, Inc. reported on their certificate of analysis for post-race test sample #15083, taken from the horse "Castle Road" which ran in the 3rd race on Monday, June 8, 2015, contained "Phenylbutazone," in the amount of 5.1 micrograms per milliliter of plasma. The trainer of record, Mr. Hubert Gaffney, was informed of this laboratory finding by the Stewards. Mr. Gaffney has until Monday, June 22, 2015 to inform the stewards of his decision concerning his right to test his horse's split sample.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:17 p.m. INQUIRY AT THE THREE EIGHTHS POLE – Claim of foul by the #3, "Spanish Dream," with rider David Amiss against the #5, "Flying Slew," and rider Carlos Luis Gutierrez, for coming in at the three eighths pole, causing him to take up on his horse. After talking to the riders involved and reviewing the films of the race, the Stewards saw no reason to take any action and made the race official. Douglas A. Portillo, scheduled to ride #1, "Half the Sky," was changed to Pierre Tomas; no double jocks mount. #2, "Choice Appeal," was selected for a pre-race blood gas test.

SECOND RACE – OFF THE TURF - POST TIME – 1:46 p.m. OFF TIME – 1:47 p.m. Julian Pimentel, the scheduled rider of #9, “Mount Coronet,” was changed to Trevor McCarthy; no double jocks mount. #2, “Duke of Perth (GB),” #6, “Slippery Slope,” #7, “Tazmanian Charlie,” #10, “Second Amendment,” and #11, “Markakis,” were scratched, as this race was taken off the turf. #12, “Pirradazis,” was scratched as an alternate. #8, “Snake Plisskin,” was selected for a pre-race blood gas test.

THIRD RACE – POST TIME – 2:16 p.m. OFF TIME – 2:18 p.m. After a two-way shake, #3, “Fashionable Frolic,” was claimed by Rose Family Stable LTD - Alejandro Reyes. #4, “Yes I Can,” was a vet scratch. #1, “Positivo,” was selected for a pre-race blood gas test. #7, “Maximus Marcus,” was selected for special post-race testing.

FOURTH RACE – OFF THE TURF - POST TIME – 2:46 p.m. OFF TIME – 2:47 p.m. #5, “Cuppy Cake,” #6, “Debbie’s Tude,” #7, “Sassy Little Cat,” #8, “Royal Renege,” #9, “Comedia,” #10, “Cool Faith,” #11, “Buttercup Bay,” and #12, “Yuzuru,” were scratched, as this race was taken off the turf. #13, “Sawyer,” and #14, “Acquant,” were scratched as alternates. #4, “Midnight Sweetie,” was selected for a pre-race blood gas test. We canceled Trifecta, Superfecta and Show wagering for this race as we were below five betting interests.

SIXTH RACE – OFF THE TURF – THE STANTON STAKES - POST TIME – 3:47 p.m. OFF TIME – 3:50 p.m. #3, “Chief Kitten,” #5, “Enjoy the Show,” #7, “Weekend Express,” #8, “My Team,” and #9, “All I Karabout,” were scratched in compliance with the stakes race provision rule 11.14.1.1. #1, “Dukin’ With Dale,” and #4, “Tiz My Valentine,” were selected for pre-race blood gas testing. We canceled Superfecta wagering for this race as we were below six betting interests. #10, “Fantasize,” stumbled at the start.
