Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

### **Administrative Hearing:**

We held a telephonic hearing for trainer Mrs. Ann Merryman, for failure to have an up to date coggins test on the horse “Chesapeake Spring,” which necessitated a scratch from the third race on Wednesday, June 17, 2015. As a result of the hearing, Mrs. Merryman was fined the sum of \$500.00 for this rule infraction.

A telephonic hearing was held on Sunday June 28, 2015 for trainer Juan Vazquez, concerning his post-race test sample #14210, taken from the horse “Edyenne” which finished second in the 1<sup>st</sup> race on Monday, May 18, 2015, contained “Methylprednisolone,” in the amount of 160 picograms per milliliter of plasma. Mr. Vazquez had waived his right, to a split sample. As a result of the hearing in this matter, Mr. Vazquez was issued a fine of Five Hundred dollars for this violation, along with one (1) point towards the ARCI Multiple Medication Violation Point System.

**THIRD RACE – POST TIME – 2:15 p.m. OFF TIME – 2:16 p.m.** Olaf Hernandez scheduled to ride #1, “Orbital Flight,” was changed to Erik Barbaran; no double jocks mount. **Hold and claim of foul** by Alex Cintron, rider of #2, “Willie Wears Pink,” against the #4, “Royal Brute,” ridden by Scott Spieth, for coming in at the half-mile pole, taking his room away. After talking to the riders involved and reviewing the films we saw no reason to take any action and made the race official. #7, “King of Versailles,” was a vet scratch. #2, “Willie Wears Pink,” was selected for a pre-race blood gas test.

We canceled Superfecta wagering for this race as we were below six betting interests. #11, “Inside Out,” stumbled at the start.

The claiming price on the #2, Slews Love,” was corrected to \$15,000 claiming instead of \$12,500 claiming, the corrected weight for the claiming price will be 124 lbs instead of 122 lbs. #3, “Easy Ten,” was claimed by Mark Powell – Randy Nunley. #3, “Easy Ten,” stumbled at the start.
