Administrative:

We held a meeting this morning with Mr. Lenny Rera, stakes coordinator and racing official. The meeting concerned the use of the racing office entry system, and the override of an ineligible horse. Mr. Rera was informed once again of the proper procedure for the overriding of entries. Mr. Rera was issued a warning that any future overrides of the computer system which resulted in a scratch, would be dealt with appropriately.
