Approved scratches for today, reviewed and filed veterinarian daily treatment sheets and blood gas test results.

Administrative Hearings:

We held a rescheduled hearing concerning, jockey Ruben Rojas and assistant starter Ruben Lemus for threatening. As a result of the hearing, Assistant Starter, Ruben Lemus was fined the sum of \$250.00 for threats made to a jockey and confrontation with a security guard while in performance of his duties. In addition, Ruben Lemus was suspended pending his completion of an Anger Management Program approved by the Stewards. The program shall be at Mr. Lemus' expense. After successful completion of the Anger Management Program, Mr. Lemus will be eligible to reapply for a DTRC license.

Equine Forensic Drug Testing:

Post-race test results from Truesdail Laboratories, Inc. revealed the following:

- All samples collected on July 4, 2015 were clear with the exceptions of samples #14524, #14613 and #14776 which were placed on hold awaiting a certificate of analysis.

FOURTH RACE – OFF THE TURF - POST TIME – 2:45 p.m. OFF TIME – 2:46 p.m. #3, “Noreen,” was a vet scratch. #1, “Happy Landing,” #2, “Tazmanian Charlie,” and #11, “Thirteenth Avenue,” were scratched as this race was taken off the turf. #9, “Mr. Magician,” was selected for a pre-race blood gas test.

FIFTH RACE – POST TIME – 3:15 p.m. OFF TIME – 3:17 p.m. Hold and claim of foul by the #3, “Final Betrayal,” ridden by Kaylia Albright against the #6, “Sheislikeice,” with rider Luis Gabriel Villanueva, for coming in causing her to check her mount in mid stretch. After talking to the riders involved and reviewing the films of the race, the Stewards saw no reason to take any action and made the race official. No Inquiry was called by the Stewards in this race. #4, “Seventyseven Ilene,” was selected for a pre-race blood gas test.
