Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. INQUIRY IN THE STRETCH RUN. Hold and claim of foul by trainer Dennis Griffith and jockey Daniel Centeno of the #3, “Bennie Y Benny,” against the #5, “Fond of Candy,” ridden by Ricardo Chiappe. The claim of foul was in reference to the #5, “Fond of Candy” coming over in front of #3, “Bennie Y Benny” during the stretch run and forcing jockey Centeno to take his horse up sharply, costing him an improved position. After talking to the riders involved and reviewing the films of the race, the Stewards disqualified the #5, “Fond of Candy,” for interference in the stretch and placed him third, moving the #2, “Balto More,” to first and the #3, “Bennie Y Benny,” to second. #3, “Bennie Y Benny,” was selected for a Stewards special post-race test. Also, #3, “Bennie Y Benny,” was claimed by Jose Serrano – James Tsirigotis. #5, “Fond of Candy,” was claimed by Michael Cook – Alison Hassig and they requested a \$113.00 all-inclusive special test. #1, “Uncle Carm,” was selected for a pre-race blood gas test.

SECOND RACE – POST TIME – 1:45 p.m. OFF TIME – 1:47 p.m. Trevor McCarthy scheduled to ride #8, “Hot Summer Storm,” was changed to Daniel Centeno; no double jocks mount. #2, “Man of Blues,” was a vet scratch. #7, “Means,” was selected for a pre-race blood gas test.

Maria Remedio scheduled to ride #8, “Sunflare,” was changed to Victor Carrasco; no double jocks mount. #1, “Mizz Martha,” was selected for a pre-race blood gas test.

FOURTH RACE – POST TIME – 2:46 p.m. OFF TIME – 2:47 p.m. Maria Remedio scheduled to ride #2, “Papas Cierva,” was changed to Victor Carrasco; no double jocks mount. #4, “Proud Ink,” was selected for a Stewards special post-race test.

FIFTH RACE – ON THE TURF - POST TIME – 3:15 p.m. OFF TIME – 3:17 p.m. Carol Cedenno scheduled to ride #2, “Scat Daddys Breeze,” was changed to Jomar Ortega; no double jocks mount. Trevor McCarthy scheduled to ride #11, “Sweet Butterfly,” was changed to Daniel Centeno; no double jocks mount. #3, “Jean’s Beauty,” was scratched as a main-track only. #5, “Windfast,” was scratched by its trainer. #9, “Sprinklesmiddle Ez,” was selected for a pre-race blood gas test.

ORDER OF FINISH – “11 - 6 - 4 - 7.” Starters - 9

SIXTH RACE – POST TIME – 3:45 p.m. OFF TIME – 3:49 p.m. Maria Remedio scheduled to ride #1, “Chain Lightning,” was changed to Victor Carrasco; no double jocks mount. #7, “Beautiful Tashy,” was selected for a Stewards special post-race test.

ORDER OF FINISH – “5 - 3 - 7 - 2.” Starters - 7

SEVENTH RACE – POST TIME – 4:17 p.m. OFF TIME – 4:23 p.m. Roberto Rosado scheduled to ride #1, “Smarty’s Legend,” was changed to Victor Carrasco; no double jocks mount. Trevor McCarthy scheduled to ride #2, “A P Bandera,” was changed to Gabriel Saez; no double jocks mount. #4, “Six Tonsafun,” was scratched by its trainer due to heat related concerns and conditions. Prior to the start, #1, “Smarty’s Legend,” got down on its knees in the starting gate and as it got up, broke through the gate and ran off down the track. The horse was apprehended by the outriders after it ran approximately one mile. Subsequently, #1 was scratched by order of the Stewards. We canceled Trifecta, Superfecta and Show wagering for this race as we were below five betting interests.

EIGHTH RACE – POST TIME – 4:50 p.m. OFF TIME – 4:52 p.m. #3, “Black Cadillac,” was selected for a pre-race blood gas test.
