### **Administrative Hearings:**

A hearing was held today for trainer Mr. Herbert Miller concerning his “Clenbuterol,” positive, for the horse “Polar Sunrise,” who had finished first in the first race on Monday, July 15, 2015. The Stewards are still in discussing sanctions for this case.

### **Equine Forensic Drug Testing:**

Post-race test results from Truesdail Laboratories, Inc. revealed the following:

- Sample #14639 which was collected on July 11, 2015 and placed on hold pending a certificate of analysis, was cleared.
- All samples collected on July 14, and July 15, 2015 were cleared.

**THIRD RACE – POST TIME – 2:16 p.m. OFF TIME – 2:17 p.m.** #4, “Lindyhop,” was a vet scratch. #7, “Jive Partner,” was selected for a pre-race blood gas test.

**ORDER OF FINISH – “5 - 2 - 7 - 3.” Starters - 6**

**FOURTH RACE – ON THE TURF - POST TIME – 2:47 p.m. OFF TIME – 2:49 p.m.** Chris Baker scheduled to ride #7, “Halton Gully,” was changed to Dana Whitney; no double jocks mount. #3, “Minor Crisis,” was scratched as a main-track only. We had a delay on making this race official, as we had no photo from photo finish. The Stewards and placing judges requested that TV control run the finish in slow motion, with all agreeing on the official order of finish. The photo finish operator Ron Ransom for Teletimer said he had never seen this problem before. Mr. Ransom is going to re-boot the system to try and fix the problem.

**INQUIRY JUST PAST THE THREE EIGHTHS POLE. Hold and claim of foul** by Scott Spieth rider of the #4, “Miss Dayna Lee,” against the #5, “Antia,” and rider Augusto Marin, for coming in at the half mile pole, causing him to take up sharply, losing his stirrups. After talking to the riders involved and reviewing the films of the race which were inconclusive, the Stewards saw no reason to take any action against the #5, and made the race official. #5, “Antia,” was selected for a Stewards special post-race test.
