**SIXTH RACE – ON THE TURF - POST TIME – 3:49 p.m. OFF TIME – 3:53 p.m.** Nik Juarez scheduled to ride #3, “Zipbopzoo,” was changed to Jevian Toledo; no double jocks mount. #7, “Laurie’s Vision,” was scratched by its trainer, as the horse ran yesterday at Saratoga. During the race there was an **.INQUIRY INTO THE FIRST TURN AND TOP OF THE STRETCH** – Going into the first turn #3, “Zipbopzoo,” bolted to the outside, carrying the #9, “Christiansted,” wide. At the top of the stretch #4, “La Murette,” ridden by Trevor McCarthy, took a bad step and then ran into the inside rail. The #4 was pulled up following the race and walked back fine with no injuries, according to Associate Commission Veterinarian Jane Teichner. The Stewards saw no reason to take any action and made the race official.
