FOURTH RACE – ON THE TURF - POST TIME – 2:48 p.m. OFF TIME – 2:50 p.m. #5, “Great Aztec,” was scratched as a main-track only. #10, “Everyday Dave,” and #11, “Nighcut,” were scratched as alternates. #3, “Private Tutor,” was a vet scratch. Following the race there was a **Hold and claim of foul** by trainer M. C. Reardon and jockey Augusto Marin of the #1, “Mangrove Pond,” against the #6, “Greek Warrior,” ridden by Tyler Conner. The claim of foul was in reference to the #6, “Greek Warrior” coming over in front of #1, “Mangrove Pond” during the stretch run and forcing jockey Marin to take his horse up. After talking to the riders involved and reviewing the films of the race, the Stewards saw no reason to take any action since the #6 maintained a straight course, and made the race official #6, “Greek Warrior,” was claimed by Gary Myers - Douglas Adams.

FIFTH RACE – POST TIME – 3:21 p.m. OFF TIME – 3:22 p.m. Nik Juarez, scheduled to ride #4, “Miss Wilby,” was changed to Ricardo Chiappe; no double jocks mount. We had a delay on making this race official, as we had no photo from photo finish. The Stewards and placing judges requested that TV control run the finish in slow motion, with all agreeing on the official order of finish. The photo finish operator Ron Ransom for Teletimer said he had a technical issue with his camera which prevented it from recording.
