Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Administrative Hearings:

We held a hearing for Jockey Mr. David Amiss concerning the excessive use of the riding crop on the horse “Classic Charlotte” in the 4th race on Tuesday, July 21, 2015. We also held a hearing for Assistant Trainer Mr. David Smith on the same matter, for instructing the Jockey to use the riding crop excessively in the race. As a result of the hearing, Mr. Amiss and Mr. Smith will be issued a fine of \$100.00 each for this violation.

FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m. Leroy Nelson, scheduled to ride #4, “Evil Lad,” was changed to Martin Solis; no double jocks mount. #4, “Evil Lad,” stumbled at the start.

SECOND RACE – ON THE TURF - POST TIME – 1:45 p.m. OFF TIME – 1:48 p.m. #2, “Supsa,” was scratched as a main-track only. #3, “Proulette,” was a vet scratch. #10, “Regalian’s Revenge,” was scratched as an alternate. #1, “Ava Again,” was selected for a pre-race blood gas test.

THIRD RACE – POST TIME – 2:17 p.m. OFF TIME – 2:20 p.m. Eiriluis Vaz, scheduled to ride. #1, “Mr. Banker,” was changed to Jose Ferrer; no double jocks mount. Eiriluis Vaz scheduled to ride. #1a, “Gotta Be Gold,” was changed to Abel Castellano Jr.; no double jocks mount. Trevor McCarthy scheduled to ride #6, “Runaway Bull,” was changed to Matthew Rispoli; no double jocks mount.

INQUIRY TOP OF THE STRETCH. Claim of foul by jockey Ricardo Chiappe of the #5, “Clearlygoodstart,” against the #6, “Runaway Bull,” ridden by Matthew Rispoli. The claim of foul was in reference to the #6, “Runaway Bull” coming over forcing the #5, “Clearlygoodstart” in at the top of the stretch and forcing jockey Chiappe to take his horse up sharply, losing his right stirrup. After talking to the riders involved and reviewing the films of the race, we disqualified the #6, “Runaway Bull,” from fourth and placed him fifth, moving the #5, “Clearlygoodstart,” up to fourth from fifth. #7, “He’ll Pay,” was selected for a pre-race blood gas test.
