Assistant Trainer Mr. David Smith has appealed stewards ruling #47-2015 concerning his \$100.00 fine that was issued by the Stewards, for instructing his Jockey to use the riding crop excessively in the fourth race on Tuesday, July 21, 2015.

**FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:16 p.m.** #3, “Warrior Wonder,” was a vet scratch. #5, “My Red Cat,” was selected for a pre-race blood gas test. We canceled Superfecta wagering for this race as we were below six betting interests.

**SECOND RACE – OFF THE TURF - POST TIME – 1:45 p.m. OFF TIME – 1:46 p.m.** Jose Flores, scheduled to ride #3, “Stourbridge Lion,” was changed to Victor Carrasco; no double jocks mount. #5, “Swig It,” and #7, “Super Spender,” were scratched as this race was taken off the turf. We canceled Superfecta wagering for this race as we were below six betting interests.

**THIRD RACE – POST TIME – 2:15 p.m. OFF TIME – 2:16 p.m.** Trevor McCarthy, named on #6, “Surfing U S A,” was changed to Victor Carrasco; no double jocks mount. #5, “Bob’s My Uncle,” was a vet scratch.

**ORDER OF FINISH – “3 - 4 - 6 - 1.” Starters - 6**

**FOURTH RACE – OFF THE TURF - POST TIME – 2:46 p.m. OFF TIME – 2:48 p.m.** This race was scheduled at seven and one half furlongs on the turf, but ran at one mile on the main track. Scott Spieth, scheduled to ride #4, “Quiet Conquest,” was changed to Daniel Centeno; no double jocks mount. Trevor McCarthy named on #5, “Soul Man,” was changed to Mathew Rispoli; no double jocks mount. #1, “Wildwood Days,” and #7, “Distorted Windfall,” were scratched as this race was taken off the turf.

**ORDER OF FINISH – “9 - 3 - 2 - 4.” Starters - 7**

**FIFTH RACE – POST TIME – 3:15 p.m. OFF TIME – 3:15 p.m.** Trevor McCarthy named on #7, “Tori’s Guy,” was changed to Victor Carrasco; no double jocks mount. #6, “War Hitch,” was selected for a pre-race blood gas test.

**ORDER OF FINISH – “4 - 2 - 7 - 1.” Starters - 7**

**SIXTH RACE – OFF THE TURF - POST TIME – 3:44 p.m. OFF TIME – 3:45 p.m.** Trevor McCarthy named on #4, “Anniebear,” was changed to Mathew Rispoli; no double jocks mount. #1, “Vale Ridge,” #5, “Lake Nation,” #6, “Ceoandthedoc,” and #8, “English Belle,” were scratched as this race was taken off the turf. #10, “Royale Rose,” #11, “Empresse,” and #12, “One Tuf Kitty,” were scratched as alternates. This race was originally scheduled at seven and one half furlongs on the turf, but was shifted to one mile on the main track. **STEWARDS INQUIRY IN THE STRETCH RUN** – The #3, “Gansett,” came out a little in during its stretch run, but at no time did it bother any other horse in the race. No hold or objection was lodged with the outriders in this race. We canceled Superfecta wagering for this race as we were below six betting interests.

**ORDER OF FINISH – “3 - 4 - 2 - 7.” Starters - 5**

**SEVENTH RACE – POST TIME – 4:15 p.m. OFF TIME – 4:17 p.m.** Trevor McCarthy, named on #1, “Moby Win,” was changed to Daniel Centeno; no double jocks mount. #3, “Hanky Doodle,” was selected for a pre-race blood gas test. #6, “Bomb Site,” was claimed by Home Team Stables – Steven Krebs.

**ORDER OF FINISH – “4 - 3 - 2 - 7.” Starters - 7**

**EIGHTH RACE – POST TIME – 4:45 p.m. OFF TIME – 4:46 p.m.** Ramon Moya, scheduled to ride #1, “Jack O Liam,” was changed to Daniel Centeno; no double jocks mount. #3, “Bobby C,” and #5, “Forest Boy,” were vet scratches. #2, “Media’s Delite,” was selected for a pre-race blood gas test. The #2, “Media’s Delite,” was pulled up by its rider, Andry Blanconear the quarter pole. The horse was examined by Commission Veterinarian, Susan Botts who reported that the horse was off in its hind quarters. Following evaluation by Dr. Botts, the horse removed from the racing surface via horse ambulance. Jockey, Andry Blanco was uninjured while dismounting the horse.

**ORDER OF FINISH – “1 - 4 - 7 - 6.” Starters - 5**

**NINTH RACE – ARABIANS - POST TIME – 5:15 p.m. OFF TIME – 5:17 p.m.** #1, “Fadhlullah Kinndah,” was selected for a pre-race blood gas test. #2, “Jewell AA,” unseated Jockey Ricardo Chiappe during the post parade, was caught by the outriders after briefly being loose and returned to compete and win the race.
