**FIRST RACE – POST TIME – 1:15 p.m. OFF TIME – 1:15 p.m.** Alexandra Jara, scheduled to ride #1, “Endless Ride,” was changed to Augusto Marin; no double jocks mount. **Hold and claim of foul** by Jockey Luis Gabriel Villanueva of the #7, “Westoniana,” against the #4, “Charli Sunshine,” ridden by Mario Rodriguez. The claim of foul was in reference to the #4, “Charli Sunshine,” coming out in front of #7, “Westoniana,” during the stretch run and forcing Jockey Villanueva to check his horse. After talking to the riders involved and reviewing the films of the race, the Stewards saw no reason to take any action and made the race official as the #7 came out during the stretch run, but was clear while doing so. No inquiry was called by the Stewards, into the running of this race. #6, “Po Mahina,” was a vet scratch. #7, “Westoniana,” was selected for a pre-race blood gas test. #4, “Charli Sunshine,” was claimed by Timothy F. Ritchey Racing Stable Inc. – Timothy F. Ritchey.

Jockey Navarro was transported to first aid and examined by EMT Kim Powers who informed us that the rider was uninjured and signed a refusal of treatment form and returned to the Jockey’s quarters. #3, “Terry Blossom,” was selected for a pre-race blood gas test.
