**Administrative:**

Blood Gas Technician Christina Cutler is substituting for Technician Barbara Dugan.

**Administrative Hearings:**

The Stewards rendered a decision in the case of Jockey Jose Vega concerning his attempted substitution of a urine sample of unknown origin and subsequently testing positive for marijuana on Monday, September 1, 2014. Mr. Vega had been issued a hearing notice for this infraction on Wednesday, October 8, 2014, but failed to show for the scheduled hearing. During that time he was suspended pending his appearance. As a result of the hearing on Tuesday, August 18, 2015, Mr. Vega will be ineligible for licensing in the state of Delaware for sixty-days, plus a \$500.00 fine for trying to falsify the test. Mr. Vega will also be required to attend and complete a drug and alcohol program, along with the payment of \$191.58 for the LabCorp Testing costs relative to his positive test.

**Post-race test results from Truesdail Laboratories, Inc. revealed the following:**

- Samples #114427 (8-4-15) and #15216 (8-5-15), which had been placed on hold awaiting a certificate of analysis, were cleared.
- Samples collected on August 11, and 12, 2015 were cleared, with the exception of sample #14483 (8-12-15) which was placed on hold pending a certificate of analysis.

**SECOND RACE – POST TIME – 1:46 p.m. OFF TIME – 1:46 p.m.** Andrew Wolfson scheduled to ride #4, “Tactical Image,” was changed to Maria Remedio; no double jocks mount. **INQUIRY IN THE STRETCH RUN** - The #2, “Concerto’s Encore,” with rider Ricardo Chiappe and #3, “Squared Away,” with rider Tyler Conner were brushing with each other down the stretch, with the inside horse coming out and the outside horse coming in. No hold or claim of foul was lodged in this race. The Stewards saw no reason to take any action and made the race official. #5, “If I Win Thelotto,” was selected for a blood gas test.
