Approved scratches for today, reviewed and filed veterinarian daily treatment sheets and blood gas test results.

Administrative Hearings:

We held a hearing this morning for trainer Ms. Gina Rosenthal concerning her entering the horse “Alluseeismytale” at two different tracks on the same day. Mrs. Rosenthal scratched her horse at Delaware Park from the 4th race on August 24, 2015 while running the horse at Laurel Park race track. Mrs. Rosenthal will be fined the sum of \$1,000.00 for this violation of D.T.R.C. rules 3.4, 3.4.1.15 and 11.2.12

Trainer Scott Lake waived his right to a hearing, concerning his entering the horse “Dixie Notion” at two different tracks on the same day. Mr. Lake scratched his horse at Delaware Park, from the 4th race on August 24, 2015 while running the horse at Laurel Park race track. Mr. Lake will be fined the sum of \$1,000.00 for this violation of D.T.R.C. rules 3.4, 3.4.1.15 and 11.2.12

We held a hearing for Apprentice Jockey Mr. Narciso Cruz concerning the excessive use of the riding crop on the horse “Will Unbridled” in the 1st race on Saturday, August 29, 2015. As a result of the hearing, Mr. Cruz will be issued a fine of \$200.00 for the violation of D.T.R.C. rule 10.9.4.
