Approved scratches for today, reviewed and filed veterinarian daily treatment sheets, and blood gas test results.

Administrative:

At 11:00 a.m. the Stewards received a phone call from jockey Gary Cruise, stating that some of the jockeys wanted to have a meeting with us at 12:00 noon. At the meeting the jockeys voiced some concerns. The first concern was that the inside turf course rail was too low, asking if there was any way to raise the rail up some. The second concern was that the hot and cold water in the jockey room showers could not be regulated very well, if at all. The riders concerns were reported to Delaware Park's Executive Director of Racing, Mr. John Mooney, shortly after the meeting with the jockeys.

After talking to the riders involved and reviewing the films of the incident, the Stewards disqualified the #8 and placed him second, behind the #7 who was moved up to first. #8, "Nines Wild Frankie," was selected for a blood gas test.
