**Delaware Park  
Stewards Ruling**

(03-2012)

*A report from the Delaware Thoroughbred Racing Commission Veterinarian showed that a pre-race blood sample taken from the horse "Wilqueen", entered in the third (3<sup>rd</sup>) race on Saturday, May 12, 2012, tested positive for Base Excess Concentration of Total Carbon Dioxide in the amount of 13.5 mmol/L, confirmed by a second test in the amount of 13.4 mmol/L. As a Result of the positive test the Board of Stewards ordered a test for a second horse scheduled to race in the fifth (5<sup>th</sup>) race on Saturday, May 12, 2012; A report from the Delaware Thoroughbred Racing Commission Veterinarian showed that a pre-race blood sample taken from the horse "Got Wings", tested positive for Base Excess Concentration of Total Carbon Dioxide in the amount of 13.0 mmol/L.*

*The trainer of the horses Wendy D. Uhacz, SS #\*\*\*-\*\*-8668, DOB 11/18/1968, was noticed for a hearing and waived her right to a hearing. Under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.2, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, and based on Ms. Uhacz's admission, she was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1.3, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.12.1.2, 15.15, 15.15.1, 15.15.2 and 15.15.3. Ms. Uhacz is fined the sum of one thousand (\$1000.00) dollars and suspended thirty (30) calendar days from Sunday, May 20, 2012, through and including Monday, June 18, 2012, for the first positive test. Pertaining to the second positive test, Ms. Uhacz is fined an additional one thousand (\$1000.00) dollar for the second violation. During the period of her suspension, she shall be denied the privileges of all grounds under the jurisdiction of the Delaware Thoroughbred Racing Commission. Refer to D.T.R.C. Rules 3.4 and 18.1. Fine must be paid within 48 hours.*
