

Stewards Ruling*



A report from Truesdail Laboratories, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample 15331, taken from the horse "Trouble Kid", who finished first in the first race on Wednesday, August 26, 2015, tested positive for "Clenbuterol". The trainer of this horse, Mr. Ramon Preciado, RCI Id 1960095, DOB 6/23/1966, availed himself to a split sample. The testing of the split sample was confirmed on 10/2/15 by The Industrial Laboratories Company.

As a result of the positive, Mr. Preciado was noticed for a hearing. Having appeared for a hearing on Tuesday, October 13, 2015 and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Mr. Preciado was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1.3, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2 and 15.3.2. Mr. Preciado is fined the sum of five hundred (\$500.00) dollars and suspended seven (7) calendar days from Saturday, October 17, 2015, through and including Friday, October 23, 2015. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Thoroughbred Racing Commission. Refer to D.T.R.C. Rules 3.4 and 18.1. Fine must be paid within 48 hours. Also for a class 3 drug violation Mr. Preciado shall incur Two (2) Points towards the ARCI Medication point system.

The horse "Trouble Kid" is disqualified from all purse monies in the first race on Wednesday, August 26, 2015. The purse is ordered redistributed as follows: 1st -Fleetwood Star; 2nd -Twelve Stone; 3rd -Golden Moon; 4th-Trouble Kid. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.
