
*Delaware Park  
Stewards Ruling*

*(109-2015)*

*A report from Truesdail Laboratories, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood and urine sample 15303, taken from the horse "Jake N Elwood", who finished first in the third race on Saturday, September 12, 2015, tested positive for "Clenbuterol". The trainer of this horse, Mr. Ramon Preciado, RCI Id 1960095, DOB 6/23/1966, exercised his right to a split sample of the blood. The testing of the split sample was confirmed on 10/22/15 by The Industrial Laboratories Company.*

*As a result of the positive, Mr. Preciado was noticed for a hearing. Having appeared for a hearing on Monday, October 26, 2015 and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Mr. Preciado was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1.3, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2 and 15.3.2. Mr. Preciado is fined the sum of One Thousand (\$1000.00) dollars and suspended fourteen (14) calendar days from Thursday, October 29, 2015, through and including Wednesday, November 11, 2015. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Thoroughbred Racing Commission. Refer to D.T.R.C. Rules 3.4 and 18.1. Fine must be paid within 48 hours. Also for a class 3 drug violation Mr. Preciado shall incur Two (2) Points towards the ARCI Medication point system.*

*The horse "Jake N Elwood" is disqualified from all purse monies in the third race on Saturday, September 12, 2015. The purse is ordered redistributed as follows: 1st –Coach Fridge; 2nd –G G's Secondchance; 3rd –Fleetwood Star; 4<sup>th</sup>-Jake N Elwood. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.*
