Stewards Ruling*

(11-2015)

A report from LGC Science, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the urine sample 50582, taken from the horse "Kay's Finesse", who finished first in the first race on Wednesday, August 27, 2014, tested positive for "Clenbuterol". The trainer of this horse, Mr. Todd Beattie, RCI Id 2018648, DOB 12/4/1962, availed himself to a split sample. The testing of the split sample was confirmed on 11/11/2014 by Industrial Laboratories.

As a result of the positive, Mr. Beattie was noticed for a hearing. Having appeared for a hearing on Monday, June 8, 2015 and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Mr. Beattie was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1.3, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2 and 15.3.2. Mr. Beattie is fined the sum of five hundred (\$500.00) dollars and suspended seven (7) calendar days from Wednesday, June 17, 2015, through and including Tuesday, June 23, 2015. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Thoroughbred Racing Commission. Refer to D.T.R.C. Rules 3.4 and 18.1. Fine must be paid within 48 hours. This Violation shall incur One (1) Point towards the ARCI Medication point system.

The horse "Kay's Finesse" is disqualified from all purse monies in the first race on Wednesday, August 27, 2014. The purse is ordered redistributed as follows: 1st - Cinder Block; 2nd - Brother Mark; 3rd - Five Thirty; 4th - Tremont Street; 5th - Kay's Finesse. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.
