

Stewards Ruling*


*A report from Dalare Associates, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample D-9392, taken from the horse "Truman's Commander", who finished first in the second race on Thursday, June 6, 2013, tested positive for "Phenylbutazone" in the amount of 6.35 micrograms per milliliter of plasma. The trainer of this horse, Mr. Kenny Smith, SS#***-**-0568, DOB 05/27/1953, waived his right to a split sample.*

As a result of the positive, Mr. Smith was noticed for a hearing. Having waived his right to a hearing and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Mr. Smith was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3, 15.1.3.1.4, 15.1.3.1.5, 15.3.1. Mr. Smith is hereby fined the sum of five hundred (\$500.00) dollars and suspended for seven (7) calendar days from Sunday, August 4, 2013 through and including Saturday, August 10, 2013. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. Refer to D.T.R.C. Rules 3.3, 3.4, 3.4.1.3 and 3.4.1.15. Fine must be paid within 48 hours.

The horse "Truman's Commander" is disqualified from all purse monies in the second race on Thursday, June 6, 2013. The purse is ordered redistributed as follows: 1st – Hope Still Springs; 2nd – Giopi(IRE); 3rd – Unconditional Resq; 4th – Chin'n Tonic; 5th – Yes Papi Yes; 6th – Dixie Emperor; 7th – Truman's Commander.. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.
