Stewards Ruling*



*A report from Dalare Associates, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample D-8965, taken from the horse "Who Dat Boy", who finished first in the fifth race on Monday, September 2, 2013, tested positive for "Phenylbutazone" in the amount of 8.37 micrograms per milliliter of plasma. The trainer of this horse, Mr. Gary Katz, SS#\*\*\*-\*\*-8495, DOB 09/17/1952, waived his right to a split sample.*

*As a result of the positive, Mr. Katz was noticed for a hearing. Having waived his right to a hearing and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Mr. Katz was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3, 15.1.3.1.4, 15.1.3.1.5, 15.3.1. Mr. Katz is hereby fined the sum of five hundred (\$500.00) dollars and suspended for seven (7) calendar days from Monday, September 23, 2013 through and including Sunday, September 29, 2013. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. Refer to D.T.R.C. Rules 3.3, 3.4, 3.4.1.3 and 3.4.1.15. Fine must be paid within 48 hours.*

*The horse " Who Dat Boy " is disqualified from all purse monies in the fifth race on Monday, September 2, 2013. The purse is ordered redistributed as follows: 1st – Ethelred; 2nd –Broad Moon; 3rd – Black Forest; 4th – Wandering Kitten; 5th – Play Bull; 6th –Shanghai Daddy; 7th – Who Dat Boy. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.*
