*Delaware Park  
Stewards Ruling*

*(01-2014)*

*Following a hearing on Thursday, October 17, 2013; the Board of Stewards issued ruling number (101-2013), finding trainer Ms. Heather Hollahan to have violated D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3, 15.1.3.1.4, 15.3.1, 15.17, 15.17.1, 15.17.1.1 and 15.17.1.1.2; after a blood sample taken from the horse "Atlantis Moon" tested positive for "Testosterone" who finished first in the ninth race on Thursday, September 12, 2013. Based on the Violation, the Stewards imposed a fine of \$500.00 Dollars and seven Calendar-day suspension of Ms. Hollahan' Trainer's license. Also the horse "Atlantis Moon" was disqualified from all purse monies.*

*On October 21, 2013, the Stewards granted a stay (Ruling 102-2013), pending the outcome after Ms. Hollahan filed an appeal for ruling 101-2013 to the Delaware Thoroughbred Racing Commission.*


*Having appeared for a hearing on November 13, 2013, before the Delaware Thoroughbred Racing Commission and after hearing the evidence, by unanimous vote of 4 to 0, the Commission affirmed Stewards ruling 101-2013 imposing the seven calendar day suspension, the \$500.00 dollar fine and the disqualification from all purse monies of the horse "Atlantis Moon".*

*Accordingly, Ms. Hollahan's Trainer's License shall be suspended for seven calendar days, which will be served from Saturday May 17, 2014 through and including Friday, May 23, 2014 and the payment of her fine is due within 48 hours of this Ruling. During the period of her suspension, she shall be denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. Refer to D.T.R.C. Rules 3.3, 3.4, 3.4.1.3.*

*The horse "Atlantis Moon" is disqualified from all purse monies in the ninth race on Thursday, September 12, 2013. The purse is ordered redistributed as follows: 1st – Sterling's Diva; 2nd – Exactanelli; 3rd – Like a Diva; 4th – Speightslegacy; 5th – Elena's Masters; 6<sup>th</sup> – Poppy's Double; 7<sup>th</sup> - Stormy monse; 8<sup>th</sup>- Rollwiththechanges. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 15.01.2(b), 17.06 and 17.07.*
