




*A report from LGC Science, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample 44502, taken from the horse "Hiram", who finished first in the second race on Thursday, June 5, 2014, tested positive for "METHOCARBAMOL"(Robaxin). The Trainer of this horse, Mr. D. Scott Peck, SS#***-**-6861, DOB 04/27/1932 availed himself to a split sample. The testing of the split sample was confirmed by the official Chemists of the University Of California at Davis.*

As a result of the positive, Mr. Peck was noticed for a hearing. Having appeared for a hearing on Tuesday, August 5, 2014; Mr. Peck voluntarily waived his right to be represented by legal counsel. Under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, and based on evidence and testimony presented at the hearing, Mr. Peck was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1.3, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2 and 15.1.3.1.3. Mr. Peck is fined the sum of One Thousand (\$1,000.00) dollars. Refer to D.T.R.C. Rules 3.3, 3.4, 3.4.1.15 and 18.1. Fine must be paid within 48 hours. This Violation shall incur One (1) Point towards the ARCI Medication point system.

The horse "Hiram" is disqualified from all purse monies in the Second race on Thursday, June 5, 2014. The purse is ordered redistributed as follows: 1st – Presidential Colors; 2nd – Enduring Star; 3rd – Francesco Punch; 4th – Sons of Missouri; 5th – Soul of the Moon; 6th – Win for the Zipper; 7th – If I Win Thelotto; 8th - Hiram. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7. (All)
