
*A report from Dalare Associates, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample D-06223, taken from the horse "Es La Mia (ARG)", who finished first in the third race on Saturday, May 12, 2012, tested positive for "Boldenone" in the amount of 340 picograms per milliliter of plasma. The trainer of this horse, Mr. Juan Vazquez, SS#\*\*\*-\*\*-6826, DOB 01/28/75, availed himself to a split sample which was confirmed by the Veterinary Diagnostic Laboratory Iowa State University to contain "Boldenone" in the amount of 427 picograms per milliliter of plasma.*

*As a result of the positive, Mr. Vazquez was noticed for a hearing. Having appeared for a hearing on Tuesday, July 17, 2012; Mr. Vazquez voluntarily waived his right to be represented by legal counsel. Under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, and based on evidence and testimony presented at the hearing, Mr. Vazquez was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3, 15.1.3.1.4, 15.3.1, 15.17, 15.17.1, 15.17.1.1, 15.17.1.1.2. Mr. Vazquez for a first offence is fined the sum of five hundred (\$500.00) dollars and suspended for seven (7) calendar days from Friday, July 27, 2012 through and including Thursday, August 2, 2012. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. Refer to D.T.R.C. Rules 3.3, 3.4, 3.4.1.3 and 3.4.1.15. Fine must be paid within 48 hours.*

*The horse "Es La Mia (ARG)" is disqualified from all purse monies in the third race on Saturday, May 12, 2012. The purse is ordered redistributed as follows: 1st – Our Silver Crown; 2nd – Belle of the Nile; 3rd – Rubble Rouser; 4th – Corner the Sun; 5th – Special Mandate; 6<sup>th</sup> – Es La Mia (ARG). This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 15.01.2(b), 17.06 and 17.07.*
