
*A report from Truesdail Laboratories, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the urine and blood sample number 14941, taken from the horse "Polar Sunrise", who finished first in the first race on Monday, June 15, 2015, tested positive for "Clenbuterol". The trainer of this horse, Mr. Herbert Miller, RCI Id 428696, DOB 09/08/1959, waived his right to a split sample.*

*As a result of the positive, Mr. Miller was noticed for a hearing. Having appeared for a hearing and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Mr. Miller was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1 and 15.1.3.1.1. Mr. Miller is fined the sum of five hundred (\$500.00) dollars and suspended seven (7) calendar days from Sunday, August 9, 2015, through and including Saturday, August 15, 2015. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Thoroughbred Racing Commission. Refer to D.T.R.C. Rules 3.4 and 18.1. Fine must be paid within 48 hours.*

*The horse "Polar Sunrise" is disqualified from all purse monies in the first race on Monday, June 15, 2015. The purse is ordered redistributed as follows: 1st -Pavlick ; 2nd -Laster; 3rd -Surge Ahead; 4<sup>th</sup> -Chief of Hearts; 5<sup>th</sup> -Dad's Glad; 6<sup>th</sup>-Polar Sunrise. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.*
