
*A report from Dalare Associates, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample D-08242, taken from the horse "Cat Wiesel", who finished first in the second race on Thursday, May 24, 2012, tested positive for "Boldenone" in the amount of 296 picograms per milliliter of plasma. The trainer of this horse, Mr. Juan Vazquez, SS#***-**-6826, DOB 01/28/75, availed himself to a split sample which was confirmed by the Veterinary Diagnostic Laboratory Iowa State University to contain "Boldenone" in the amount of 382 picograms per milliliter of plasma.*

As a result of the positive, Mr. Vazquez was noticed for a hearing. Having appeared for a hearing on Tuesday, July 17, 2012; Mr. Vazquez voluntarily waived his right to be represented by legal counsel. Under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, and based on evidence and testimony presented at the hearing, Mr. Vazquez was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3, 15.1.3.1.4, 15.3.1, 15.17, 15.17.1, 15.17.1.1, 15.17.1.1.2. Mr. Vazquez for a second offence is fined the sum of one thousand (\$1,000.00) dollars and suspended for fifteen (15) calendar days from Friday, August 3, 2012 through and including Friday, August 17, 2012. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. Refer to D.T.R.C. Rules 3.3, 3.4, 3.4.1.3 and 3.4.1.15. Fine must be paid within 48 hours.

The horse "Cat Weisel" is disqualified from all purse monies in the second race on Thursday, May 24, 2012. The purse is ordered redistributed as follows: 1st – Harbor Fox; 2nd – Cryptic Kate; 3rd – Trippadeedooda; 4th – Cat Wiesel. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 15.01.2(b), 17.06 and 17.07.
