

A report from Truesdail Laboratories, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample number 14911, taken from the horse "Mizz Martha", who finished first in the first race on Saturday, June 13, 2015, tested positive for "Fluphenazine". The trainer of this horse, Ms. M.C. Reardon, RCI Id 2043872, DOB 05/01/1980, availed herself to a split sample which was confirmed on July 22, 2015, by Industrial Laboratories.

As a result of the positive, Ms. Reardon was noticed for a hearing. Having appeared for a hearing and under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, Ms. Reardon was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1 and 15.1.3.1.1. Based on the testimony at this hearing and due to mitigating circumstances Ms. Reardon is fined the sum of five hundred (\$500.00) dollars and suspended fifteen (15) calendar days from Saturday, August 15, 2015, through and including Saturday, August 29, 2015. During the period of her suspension, she shall be denied the privileges of all grounds under the jurisdiction of the Delaware Thoroughbred Racing Commission. Refer to D.T.R.C. Rules 3.4 and 18.1. Fine must be paid within 48 hours. This Violation shall incur six (6) Points towards the ARCI Medication point system.

The horse "Mizz Martha" is disqualified from all purse monies in the first race on Saturday, June 13, 2015. The purse is ordered redistributed as follows: 1st -Madre Ditutticapi; 2nd -Frisbee; 3rd -Galpal; 4th -Sorta Sassy; 5th -Antia; 6th-Aragonesa; 7th - Mizz Martha. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 17.6.1 and 17.7.
