**Delaware Park  
Stewards Ruling**

**(82-2012)**

*Following a hearing on Tuesday, July 17, 2012; the Board of Stewards issued ruling number (31-2012), finding trainer Mr. Juan Vazquez to have violated D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3, 15.1.3.1.4, 15.3.1, 15.17, 15.17.1, 15.17.1.1 and 15.17.1.1.2; after a blood sample taken from the horse "Es La Mia (ARG)" tested positive for "Boldenone" who finished first in the third race on Saturday, May 12, 2012. Based on the Violation, the Stewards imposed a fine of \$500.00 Dollars and seven Calendar-day suspension of Mr. Vazquez' Trainer's license. Also the horse "Es La Mia (ARG)" is disqualified from all purse monies*


*On July 23, 2012, the Stewards granted a stay (Ruling 37-2012), pending the outcome after Mr. Vazquez filed an appeal for ruling 31-2012 to the Delaware Thoroughbred Racing Commission. Having appeared for a hearing on October 10, 2012, before the Delaware Thoroughbred Racing Commission and after hearing the evidence, by unanimous vote the Commission affirmed Stewards ruling 31-2012 imposing the seven calendar day suspension and the \$500.00 dollar fine. The Commission instructed the Stewards to advise Mr. Vazquez of the effective dates of his suspension.*

*Accordingly, the Stewards hereby advise Mr. Vazquez that his Trainer's License shall be suspended for seven calendar days, which will be served the first 7 days of the 2013 Delaware Park racing season and the payment of his fine is due within 48 hours of this Ruling. During the period of his suspension, he shall be denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. Refer to D.T.R.C. Rules 3.3, 3.4, 3.4.1.3.*

*The horse "Es La Mia (ARG)" is disqualified from all purse monies in the third race on Saturday, May 12, 2012. The purse is ordered redistributed as follows: 1st – Our Silver Crown; 2nd – Belle of the Nile; 3rd – Rubble Rouser; 4th – Corner the Sun; 5th – Special Mandate; 6<sup>th</sup> – Es La Mia (ARG). This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 15.01.2(b), 17.06 and 17.07.*
