Stewards Ruling*



*A report from Dalare Associates, Inc., the official Chemists of the Delaware Thoroughbred Racing Commission, showed that the blood sample D-06755, taken from the horse "Lady Olivia", who finished eight in the seventh race on Saturday, August 25, 2012, tested positive for "Trenbolone" in the amount of 65 picograms per milliliter of plasma. The trainer of this horse, Ms. Carla Morgan, SS#\*\*\*-\*\*-7429, DOB 4/6/1949, waived her right to a split sample.*

*As a result of the positive, Ms. Morgan was noticed for a hearing. Having appeared for a hearing on September 18, 2012; Ms. Morgan voluntarily waived her right to be represented by legal counsel. Under the authority of the Stewards, refer to D.T.R.C. 3.3.1, 3.3.3, 3.3.10, 3.4.1, 3.4.1.7, and based on evidence and testimony presented at the hearing, Ms. Morgan was found to be in violation of D.T.R.C. Rules 7.3.1, 7.3.6, 7.3.9, 10.8.1, 10.8.1.3, 15.1, 15.1.1.1, 15.1.1.2, 15.1.2.2, 15.1.2.6, 15.1.2.7, 15.1.3.1, 15.1.3.1.1, 15.1.3.1.2, 15.1.3.1.3, 15.1.3.1.4, 15.3.1, 15.17, 15.17.1, 15.17.2 Ms. Morgan is fined the sum of one thousand (\$1,000.00) dollars and suspended for fifteen (15) calendar days, which will be served consecutively with ruling 91-2012, for a total of 22 calendar days at the start of the 2013 Delaware Park racing season and the payment of her fine is due within 48 hours of this Ruling. During the period of her suspension, she shall be denied the privileges of all grounds under the jurisdiction of the Delaware Racing Commission. Refer to D.T.R.C. Rules 3.3, 3.4, 3.4.1.3 and 3.4.1.15.*

*The horse "Lady Olivia" is disqualified from all purse monies in the seventh race on Saturday, August 25, 2012. This ruling in no way affects the pari-mutuel wagering in this race. Refer to D.R.C. Rules 15.01.2(b), 17.06 and 17.07.*
